ISO 9001:2015 - QMS

ISO 9001:2015 sets out the criteria for a quality management system. It can be used by any organization, small or large and irrespective of its area of business, be it hotels, hospitals, educational institutions, sales organizations, manufacturing industries, etc.

ISO 14001:2015 - EMS

ISO 14001:2015 sets out the criteria for an environmental management system and can be certified to. It maps out a framework that a company or organization can follow to set up an effective environmental management system. It can be used by any organization regardless of its activity or sector.

ISO 20000-1: 2018 - ITMS

ISO 20000-1:2011 is the formal specification for IT Service Management. It clearly defines all the requirements you need to deliver managed IT services of an acceptable quality for your customers.

ISO 22000-2018 - FSMS

ISO 22000 is a Food Safety Management System that can be applied to any organization in the food chain, farm to fork. Becoming certified to ISO 22000 allows a company to show their customers that they have a food safety management system in place.

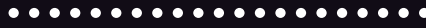
